FY 2017 CDBG – Development of the soccer field

The silt fence has been installed in advance of the project start-up. We are still waiting for the contractor's schedule.

FY 2020 CDBG – Applications are due in the beginning of January. The Borough is able to apply for two projects. It is recommended we continue with the replacement of the sanitary sewer on Golf Road as one of the projects. Public input will be obtained on December 18, 2019 at 7:15PM.

2018 PA Small Water and Sewer Grant

We can begin the sewer replacement in the Chestnut St area whenever the Borough is ready to authorize it. This is a reimbursement grant. The Borough must pay the contractor first, and then request reimbursement.

2020 PA Small Water and Sewer Grant

The grant has been announced and the due date is December 13, 2019. The project size is between \$30,000-\$500,000 and the Borough match is 15%. We recommend for the project location to be 14th street between Main and Chestnut. A resolution is required and is attached for the Council's consideration.

Ordinary Street and Sewer Maintenance

A to U has ordered the inlet box for the inlet at Crestview/Southridge. They are also replacing the inlet on the opposite side of the street. In addition, we are awaiting the contractor's schedule to do the patch repair on Ridge opposite Borough Hall.

MS4 Separate Storm Sewer Permit

The annual report was submitted to DEP.

Main Street Intersection Improvements

Intersection improvements are being proposed at the intersections of Main Street at 5th and 6th Streets. Would the Borough prefer for the traffic signal posts and overhead arms to be painted black as opposed to the current unpainted aluminum poles and arms? This would be done with no added cost to the Borough and is much more decorative than the current traffic signals.

However, please consider the maintenance of the paint that will need to be done in the future. Also, can this project use the same traffic detour plan as was used several years ago for the new railroad crossing “diamond plates” installed by CSX RR? That detour used Borough streets Church Lane, S. 70th St., and Woodland Ave. Please verify with police and other agencies if the same route is acceptable.

Stormwater Tip:

It matters how and where you take care of your car. When you are working on your car, be sure to catch your used fluids in safe containers that you can take to a recycling center. Never dispose of these chemicals down a storm drain. If you spill anything, try to mop it up quickly.

Dear Mr. President, Board of Directors, and General Membership,

During the month of October the company responded to 88 calls for service. These calls included 1 working fire in Collingdale

On October 25, Co. 4 and other mutual aid companies were dispatched to the 900 block of Bartram Ave in Collingdale for the house fire. Engine 4 quickly responded and while en route was notified it was a working fire. Engine 4 arrived as first engine and began fire suppression and searches for possible victims. Truck 4 also made the response and assisted with fire suppression and overhaul on the 2nd and 3rd floors. Co. 4 was in service for 3 hours before being released by Bartram Ave command. Companies 56 and 17 covered the Borough while we operated on this extra alarm fire. *No FF injuries were reported at this incident.*

On 10/31 Engine 4 assisted with the annual "Trunk-or-Treat" at the Rec. Center and handed out candy and fire prevention literature and novelty toys to the children and parents of the town. The crew happily assisted with the event for the entire 3 hour duration and we look forward to participating next year!


